THE **ADHERTEC DF881** IS A DOUBLE SIDED WOVEN COTTON CLOTH TAPE COATED ON THE EXPOSED SIDE WITH A RUBBER ADHESIVE SPECIALLY FORMULATED FOR CLEAN REMOVAL FROM SUBSTRATES, AND COATED WITH AN AGGRESSIVE NATURAL RUBBER ADHESIVE ON THE LINER SIDE. THIS TAPE IS USED IN MANY DIFFERENT APPLICATION INCLUDING INDUSTRIAL MOUNTING, SPLICING AND HOLDING, HOLD-DOWN CARPET FOR TRADE EXPOSITIONS, CONSTRUCTIONS AND RENOVATIONS.
